The Board of County Commissioners (BOCC) of Kay County, Oklahoma, met in regular session at 9:00 o'clock a.m. on Monday, March 23, 2020, the meeting was posted for public information on March 20, 2020, at 8:50 a.m. on the Courthouse front door, Commissioners Court, and basement handicapped entrance of the Kay County Courthouse in Newkirk, Oklahoma.

Chairman John Wilson called the meeting to order. Those present were as follows: Jason Shanks, Member; Jack Godberson, Member; Brian Hermanson, District Attorney (DA); Christy Kennedy, Kay County Treasurer; Susan Keen, Kay County Assessor; Steve Kelley, Kay County Sheriff; Marilee Thornton, Kay County Clerk; Judge David Wilkie; Dennis Bonewell, Kay County Emergency Management Director; Tammy Reese, Secretary/Kay County Clerk. (See sign in sheet).

Chairman John Wilson led the Flag Salute.

Motion was made by Godberson and seconded by Shanks approving regular meeting minutes of March 16, 2020. Motion carried: Godberson, aye; Wilson, aye; Shanks, aye.

Appeal made by Steve Boone, President of Security Abstract Company and Security Title: Mr. Boone asked the BOCC for permission to have one (1) Security Abstract employee to have access to the County Clerk's office for one (1) hour each day during the public closing of the courthouse. He told there are critical components of research that is required by abstracters and they are required to double check land records that are filed in the county clerk's office. Commissioner Godberson asked him if he could search on-line; Mr. Boone stated some but not for all records. Godberson stated if the BOCC allows one person in that we would soon have a chain of people wanting in the courthouse. He said last Monday the BOCC made the decision to close the courthouse completely with no restricted access; he said at that time it was decided all or none. Mr. Boone said he would argue his business is somewhat different because they are bonded to use records. Clerk Reese told Mr. Boone the clerk's office would be happy to accommodate him in any way possible.

Motion was made by Godberson and seconded by Shanks denying appeal made by Steve Boone, Security Abstract Company, requesting limited access for one (1) Security Abstract employee to be allowed in the County Clerk's office for one hour each day during the public closing of the courthouse. Motion carried: Godberson, aye; Wilson, aye; Shanks, aye.

Motion was made by Shanks and seconded by Godberson approving Kay County 401(a) Plan-Amendment One-2020 regarding certain benefits. DA Hermanson approved as to form. Motion carried: Godberson, aye; Wilson, aye; Shanks, aye.

Motion was made by Shanks and seconded by Wilson approving Ad Valorem Reimbursement Fund, for loss of revenue due to exemption of new or expanded manufacturing facilities in 2018 for 2019 tax year in the amount of \$10,870,889.00. Assessor Susan Keen said the county files this every year to get reimbursed by the state. Motion carried: Godberson, aye; Wilson, aye; Shanks, aye.

Motion was made by Godberson and seconded by Shanks approving Contract and Agreement for Juvenile Detention Services between the County of Comanche and the County of Kay, \$40.00 per juvenile/detainee, per day. DA Hermanson approved as to form; Sheriff Kelley stated he wanted BOCC to accept Contract. Motion carried: Godberson, aye; Wilson, aye; Shanks, aye.

Motion was made by Shanks and seconded by Godberson tabling rebidding Tanker Remount and Equipment for Kildare Fire Department. Motion carried: Godberson, aye; Wilson, aye; Shanks, aye.

Road and Bridge Projects/Circuit Engineering District (CED) No. 8 Road and Bridge Projects: Commissioner Godberson told crews hauled rock to stock pile from APAC, cleaned out culvert pipe on LaCann, serviced vehicles and worked in shop and patched holes on Hubbard and Kildare Rd.

Commissioner Shanks told his crews are working in the shop. He said as soon as the roads dry crews will start hauling rock and blading. Shanks said River Ridge Construction is working on Bridge #55 today.

Commissioner Wilson said crews hauled rock from APAC for FEMA Projects, trimmed trees, filled holes in roads in Nardin and south of Blackwell, picked up asphalt, serviced equipment and picked up a truck that was being repaired in Winfield. He told crews bladed this past weekend due to weather situation.

Motion was made by Wilson and seconded by Shanks approving Bridge Application Form Emergency and Transportation Revolving Fund Program on the following bridges: Bridge CN#45 NBI#08568 Str.

Motion carried: Godberson, aye; Wilson, aye; Shanks, aye.

Motion was made by Wilson and seconded by Shanks tabling Contract Agreement Emergency and Transportation Revolving, ETR Fund by and between Kay County BOCC and the Oklahoma Cooperative Circuit Engineering Districts Board (OCCEDB) on the following: Project Number: ETRCB8-36-3(36)20-requested amount-\$115,000.00, anticipated reimbursement fund FEMA Funds. Wilson said he didn't believe the anticipated reimbursement funds were to come FEMA so he will check. Motion carried: Godberson, aye; Wilson, aye; Shanks, aye.

Motion was made by Shanks and seconded by Godberson approving to go out for sealed bids on removal of existing 24' x 53' bolt-together framed building with all existing fixtures and wiring included (building is located on courthouse property). Shanks told this building was the maintenance shed on courthouse property and stated the building is in great shape; he said he would speak with Matt Graves, Architects In Partnership (AIP) to get a dead line of the date it needs to be removed. Motion carried: Godberson, aye; Wilson, aye; Shanks, aye.

Motion was made by Shanks and seconded by Godberson approving Resolution No. 19, 20-114, a resolution memorializing board action regarding closing courthouse to the public because of a widespread threat of the COVID-19 pandemic. DA Hermanson said Kay County was one of the first courthouse's to be close and told Kay County has been followed by many other counties. DA Hermanson said at the time the courthouse was closed to the public a Resolution was not in place. Motion carried: Godberson, aye; Wilson, aye; Shanks, aye.

Discussion continued regarding the closings.

Motion was made by Shanks and seconded by Godberson approving the following Transfer of Funds: Hwy. Dist#2 Maintenance & Operation-\$4,604.59 to BIA 6 Bridges Project. Motion carried: Godberson, aye; Wilson, aye; Shanks, aye.

DA Hermanson left the meeting.

Motion was made by Shanks and seconded by Godberson approving Payroll with warrants to be released on March 30, 2020, Maintenance & Operation Claims and Blanket Purchase Orders. Motion carried: Godberson, aye; Wilson, aye; Shanks, aye.
