Quotes for Annex/OSU Extension Buildings Security Camera System: Sheriff Kelley said he received five (5) quotes from the seven (7) sent. Quotes received: Falco Alarm Company-Stillwater-\$9,435.00; American Telephone-Ponca City-\$10,199.00; Hi-Fi Systems-Ponca City-\$13,375.00; Johnson Controls-Tulsa-\$27,986.78; Summit Fire & Security-Edmond-\$32,465.00. He told 22 additional cameras will need to eventually be installed in the courthouse with a total of around 60 cameras.

Motion was made by Godberson and seconded by Shanks approving and accepting the quote from American Telephone- \$10,199.00 to purchase security cameras and associated equipment for the Annex and OSU Extension buildings to be paid out of the Courthouse Security Capital Outlay account, per recommendation by Sheriff Kelley. Sheriff stated his reasons for not accepting the lowest quote: Faster response to warranty repairs, American Telephone has installed existing associated cabling (bid accepted), and better quality of system setup for operation.
