Motion was made by Wilson and seconded by Shanks approving the following Proposals regarding changes for the Kay County Courthouse Remodel & Addition-Phase 2: Plaster ceiling removal (ASI #04)-34,990.08; Pipe chases at window locations (ASI #02)-\$265.00; Light switches at elevator (RFI #23)-\$539.55; Slab area at door ST001 (RFI #20)-\$2,475.30; Door glazing credit-(\$368.88); Abatement (through 3/28)-\$28,212.10; Jail cell removal (RFI #10)-\$2,664.84; Elevator steel beam (RFI #13)-\$622.23. Wilson said these changes/proposals were not addressed in the bid packages. Motion carried: Wilson, aye; Shanks, aye.
