The Board of County Commissioners (BOCC) of Kay County, Oklahoma, met in regular session at 9:00 o'clock a.m. on Tuesday, June 20, 2023, the meeting was posted for public information on June 16, 2023, at 8:50 a.m. at the Commissioners Room, west entrance of the Kay County Administration Building in Newkirk, Oklahoma, and on the Kay County Website.

Chairman Shane Jones called the meeting to order: Commissioners: Jason Shanks, Member, present; Jeff Kreger, Member, present. Others present were as follows: Shawna Taylor, Kay County Assistant District Attorney (ADA); Rhonda Stephens, Kay County Treasurer-Elect; Janell Leaming, Kay County Assessor; Don Jones, Kay County Detention Center Director; Dennis Bonewell, Emergency Management Director; Dan Hesson, Citizen; Kip Bird, American Telephone; Everett Brazil, Newkirk Herald Journal; Claude Williams, Taxpayers for Transparency; Tammy Reese, Secretary/Kay County Clerk.

Chairman Shane Jones led the flag salute.

Motion was made by Shanks and seconded by Kreger approving the regular meeting minutes of June 12, 2023. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Fusion Connect to GoTo Connect through American Telephone: Kip Bird stated Kay County has voiceover IP meaning the county currently uses fusion with unlimited long distance and have been on this for 6-9 years at a cost of around \$290 a month, if the county goes to GoToConnect it would lower the cost to \$225 a month. Kip Bird explained how both services work. He said if the county decides to go with GoToConnect there would be a one-time upfront switch-over cost of \$361. Bird said one of the commissioners would need to E-sign the agreement if the county chooses GoToConnect.

Motion was made by Shanks and seconded by Jones approving changing from Fusion Connect to GoTo Connect through American Telephone at approximately \$225 a month fee with a one-time upfront switch-over cost of approximately \$361, and authorizing Commissioner Jason Shanks to E-sign the agreement. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Motion was made by Shanks and seconded by Kreger approving a Software Lease and Maintenance Agreement by and between Kay County Treasurer and TM Consulting, Inc. DA Hermanson approved as to form. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Motion was made by Shanks and seconded by Kreger approving the KellPro Software and Service Agreement by and between KellPro, Inc. and Kay County Clerk. DA Hermanson approved as to form. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Motion was made by Shanks and seconded by Jones approving the Oklahoma State Department of Health Business Associate Agreement by and between the Oklahoma State Department of Health and R. K. Black to provide maintenance to the copy machines for the Kay County Health Department. DA Hermanson approved as to form. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Motion was made by Shanks and seconded by Kreger approving the Ambulance Service Agreements by and between Kay County and the following: City of Blackwell, City of Newkirk, City of Ponca City, and City of Tonkawa. DA Hermanson approved as to form. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Motion was made by Shanks and seconded by Kreger approving Resolution No. 22, 23-135, a resolution of the BOCC for Kay County, Oklahoma regarding the administration of an additional one-third or one percent (1/3 of 1%) county sales tax upon the gross proceeds or gross receipts derived from all sales taxable under the Oklahoma Sales Tax Code, which provides that 100% of all revenues derived therefrom would be apportioned equally among participating volunteer fire and emergency medical service providers located and operating with the corporate boundaries of Kay County, Oklahoma, with correction in the agreement naming the County Clerk as the purchasing agent instead of Kay County Dist#2. DA Hermanson approved as to form. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Motion was made by Kreger and seconded by Shanks approving Resolution No. 22, 23-134, directing the Treasurer to forward all Rural Fire and Ambulance Service District Sales Tax Collections to the Rural Fire ST Fund 1321 and the Ambulance Service District ST Fund 1303, and Use Tax Funds pertaining to said entities shall be disbursed for the Rural Fire and Ambulance Services Districts to Fund 1301 and shall be disbursed to said funds by the County Clerk. DA Hermanson approved as to form. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Motion was made by Shanks and seconded by Jones approving a Professional Legal Services Contract by and between the BOCC and Tisdal & O'Hara, PLLC, to represent Kay County with regards to certain Wind Farm ad valorem tax issues. Commissioner Shanks asked if Kay County is still partnering with Grant County for these services; Assessor Leaming answered yes. DA Hermanson approved as to form. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Motion was made by Shanks and seconded by Kreger approving Agreements between the BOCC and the following to have remote terminal capabilities with the Assessor's office: Gene Wilkerson. DA Hermanson approved as to form. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

No action was taken on a Contract with Western Plains Youth & Family Services, in Kay County for services at Northwest Oklahoma Regional Juvenile Detention Center, \$68.00 per child per day, per the request of Sheriff Steve Kelley.

The unused amount of ARPA funding that was given to the Kay County Detention Center (KCDC): Director Jones said from the ARPA funding that was first given to the KCDC for a tracker scanning device and a water softener; he said both items came in much less than what was anticipated and he would like to use the unused amount to purchase a tractor/loader, brush hog, and a new tilt service.

Motion was made by Shanks and seconded by Kreger approving to use the unused amount of ARPA funding that was given to the Kay County Detention Center to purchase a new tractor/loader, brush hog, and a new tilt skillet for food service. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Road and Bridge Projects/Circuit Engineering District (CED) No. 8 Road and Bridge Projects: Commissioner Jones said crews cleaned out a ditch and removed trees on Cowboy Hill Rd., repaired and replaced road signs on county roads, and put in a culvert on Furguson east of LaCann and east of Hwy. 77, drove roads and drained the water off the roadways in the district, sprayed around signs and bridges, graded, mowed, and hauled material to roads and stockyard.

Commissioner Shanks said River Rd. and Bear Creek Fire Department helped to put out a fire on a bridge. He said Saturday there was a wreck on Peckham Rd., and stated the bridge will need to be replaced. Shanks said crews will also be blading, and hauling rock and dirt.

Commissioner Kreger said crews dug shale at the pit, hauled rock and shale to the roads, graded roads, and hauled rock from Burbank and will finish hauling from Sober. He said crews are taking final pictures for a large FEMA PW#1013 project. He told a FEMA representative came and took pictures for a small project closeout for Disaster #4438. Kreger stated this should close out all the small projects for Kay County Dist#3. He mentioned that Coleman Riverbank Project is being worked on by Paradigm contractors and noted that will be the last large FEMA Project from 2019.

Motion was made by Jones and seconded by Kreger approving the following Public Service/Pipeline Crossing Line Installations: Kay Electric Cooperative, SE4/SE4 S22 T26N R1E ending NW4/NW4 S12 T26N R1E, "T" Street, Dist#1. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Motion was made by Kreger and seconded by Jones approving the following Resolution for Disposing of Equipment: Res#22, 23-136, Hwy. Dist#2, shop fan, junked. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Motion was made by Shanks and seconded by Kreger approving the County Treasurer's Summary of Collections May 2023 Monthly Report. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Motion was made by Shanks and seconded by Jones approving the following Kay County Monthly Reports for May 2023: Assessor, County Clerk, Election Board. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Motion was made by Shanks and seconded by Kreger approving the following Resolutions to deposit funds: Res#22, 23-132, Hwy.
