The Board of County Commissioners (BOCC) of Kay County, Oklahoma, met in regular session at 9:00 o'clock a.m. on Monday, August 16, 2021, the meeting was posted for public information on August 13, 2021, at 8:50 p.m. on the Courthouse front door, Commissioners Court, basement handicapped entrance of the Kay County Courthouse in Newkirk, Oklahoma, and Kay County Website.

Chairman Jason Shanks called the meeting to order. Commissioners: Jack Godberson, Member, present; John A. Wilson, Member, present. Other's present were as follows: Brian Hermanson, District Attorney (DA); Susan Keen, Kay County Assessor; Steve Kelley, Kay County Sheriff; Christy Kennedy, Kay County Treasurer; Brenda Medlock and Liz Nicholson, OSU Extension; Dennis Bonewell, Emergency Management Director; Rick Taylor; Mark Devlin, Attorney for Rural Water District No. 7; Darlene Engelking, Ponca City News; Claude Williams, Taxpayers for Transparency; Tammy Reese, Secretary/Kay County Clerk.

Chairman Jason Shanks led the flag salute.

Motion was made by Godberson and seconded by Wilson approving regular meeting minutes of August 9, 2021. Motion carried: Godberson, aye; Wilson, aye; Shanks, aye.

A written report was submitted to the Commissioners prepared by Donna Parker, Oklahoma Court Services, presenting the number of community service hour's defendants are working the projects they are involved in (Ms. Parker was not present). Total monthly completed hours for new community service clients-9, regular community service hours completed-47, sanction community service hours-80 and community service offender completions-12. Completed events for July where clients were busy mowing, weed eating, moving, cleaning, painting, and feeding animals: Ponca City Fire Department, Tonkawa Cemetery, Blackwell School, Kay County Courthouse, Northern Oklahoma Human Society. Upcoming events: Ponca City Fire Disc Golf, My Favorite Things, Northern Oklahoma Humane Society, and Attucks Community Center.

Motion was made by Godberson and seconded by Wilson approving a Notice of Hearing upon Petition to Incorporate and Organize a Rural Water District in Kay County, Oklahoma to be held during a BOCC meeting on Monday, August 30, 2021 at 9 a.m. (Rural Water District No. 7). Attorney Mark Devlin said upon passing this petition to incorporate this water district it will statutorily allow the district to receive funding that they otherwise would not be able to receive. Motion carried: Godberson, aye; Wilson, aye; Shanks, aye.

OSU Extension office July 2021 activities: Brenda Medlock began by thanking the BOCC for allowing them to highlight their programs July activities. She told Shannon Mallory was not present due to an inservice he was attending. Ms. Medlock said Mallory held workshops and held the annual Master Gardeners tomato contest. She told their summer intern left at the end of July; while here he presented workshops on meat judging, etc. Medlock said that OSU Extension held a two-day sewing camp at the Kay Room in Blackwell where projects were completed with 11 girls attending, plus volunteers.

Liz Nicholson said that Kay County's Colton Tripp was elected Northeast District State Representative and Key Club Award at the 100<sup>th</sup> 4-H Roundup. She said during the Honor Assembly Colton was awarded a \$1,200 scholarship through the Oklahoma State 4-H Record Book Scholarship program. Ms. Nicholson told Colton would travel the state and speak to other 4-Hers.

Nicholson spoke about an officers training and retreat and stated the team leader program has grown and now offered two more officers, a photographer and a historian. She told about these two new positions. She ended by saying Kay County has a very rich program.

Motion was made by Godberson and seconded by Wilson approving Contract by and between the Kay County Health Department and Gary Lockett to provide Directly Observed Therapy and related services to tuberculosis (TB) patients. Motion was made by Shanks and seconded by Wilson approving Resolution No. 21, 22-46 to support the Daughters of the American Revolution, approval of placing a permanent marker and authorizing location of marker along with a letter of support to commemorate the 250<sup>th</sup> anniversary of our country (July 4, 2027). ARPA funding: Chairman Shanks said he wanted to inform Wilson and Godberson about CED#8 hiring a consultant regarding the ARPA funds and how the funds could be spent. He said if "extra help" was needed Kay County could hire a consultant for assistance. Shanks said he this would be a topic at the next CED meeting.

Road and Bridge Projects/Circuit Engineering District (CED) No. 8 Road and Bridge Projects: Commissioner Godberson told crews bladed, hauled material, sprayed and mowed roads district wide, boom mowed, cleaned out ditches on LA Cann south of Canteen and Prentice Rd., put in a culvert on Furguson and Kildare Rd.

Commissioner Shanks said he would be going to pick up a new grader, told two trucks were broke down and that crews are blading roads.

Commissioner Wilson told his crews hauled rock and shale to FEMA sites, bladed roads, dug shale at the pit, mowing road ways, picking up trash, and repairing signs, replaced two culverts, cleaned out trees and a beaver dam on Gate Rd.
